LESSON REGISTRATION FORM 2025-2026

Effective August 2025

GCA offers private piano lessons that are billed monthly through the business office. Lessons begin when they are scheduled by the instructor (usually Sept. 1) and are expected to run through the academic year. The cost for lessons is prorated for the academic year and is a per lesson cost, guaranteeing students 30 lessons per year. Two recital opportunities are provided and are counted toward the lesson total.

Lessons are given during school hours or after school as the instructor's schedule permits. 30-minute lessons are standard. Students will need to commit to practice time at home (like homework) and must have an instrument on which to practice. The instructor is happy to offer information about an appropriate instrument and the best places to purchase one.

The lesson schedule is based on 30 lessons for the school year, as stated above. Lessons are billed in nine equal installments, with the first being attached to this form. The total cost for lessons is 140.00 per month payable in nine installments of \$140.00. The first payment is due with this registration form, either in the form of a check or credit card. The remaining payments will be billed through FACTS. (If paid by credit card, a 2.5% charge will be added).

The school administration implementing these policies reserves the option to review them considering relevant circumstances as it deems appropriate.
